### ATO's Audit Targets

The Australian Taxation Office has set up a new page on its website called 'Building Confidence', which talks about its compliance activities and the amounts of tax and penalties it has collected in 2014 from various initiatives. The ATO does say that they think the tax and superannuation systems should be designed and operated for the majority of people who do the right thing, rather than for the few who do not. Some of the areas that the ATO has stated it will be focusing on are:

- Work-related expenses:
  - Overnight travel;
  - Motor vehicle expenses for travelling between home and work; and
  - > The work-related proportion of use for computers, phones and other electronic devices.
- Rental property expenses:
  - Excessive deductions being claimed for holiday homes (deductions should be limited to the amount of income earned, or to the number of days actually rented out at a commercial rate);
  - > Husbands and wives inappropriately splitting rental income and deductions for jointly owned properties; and
  - > Interest deductions being claimed for the private proportion of loans.
- Tax professionals failing their own obligations, such as lodging returns and paying liabilities.
- Cash economy:

- The building and construction industry; and
- The restaurant, café and takeaway industry.

Contractors – employers misusing contracting arrangements with the intention of avoiding employment overheads.

### Superannuation Concessional Contributions Thresholds

The Australian Taxation Office has updated the superannuation rates and thresholds for 2015/16.

### **Concessional Contributions Cap:**

Concessional contributions include:

- Employer contributions (including contributions under a salary sacrifice agreement); and
- Personal contributions claimed as a tax deduction by a self-employed person.

Income Year	Amount of Cap	
2015/2016	\$30,000	
2014/2015	\$30,000	

#### **Temporary Concessional Cap:**

Income Year	Age of Taxpayer	Amount of Cap
2015/2016	49 years or over on 30 June 2015	\$35,000 *
2014/2015	49 years or over on 30 June 2014	\$35,000 *

(\*) As the higher temporary cap of \$35,000 is not indexed, it will cease when the general cap reaches \$35,000 through indexation

#### Superannuation Guarantee Rate:

The superannuation guarantee rate is 9.5% from 1 July 2014 (up from 9.25% in 2013/2014). The superannuation guarantee rate will remain at 9.5% until 1 July 2021 when it will increase to 10%. It will then increase by 0.5% increments until it reaches 12% from 1 July 2025.
